

Laura Davick, Founder/Director of External Affairs Crystal Cove Alliance, Newport Coast

As founder of Crystal Cove Alliance (CCA), Laura Davick spearheaded the campaign to prevent a planned luxury resort from taking over Crystal Cove. Davick proposed an alternative plan to restore the Cove's cottages, which included a combination of overnight rentals and educational programs. Today, CCA has become one of the most successful public-private partnership models in the history of California State Parks. As director of external affairs, Davick continues to fight for sustainability of the Cove - CCA now has numerous educational programs, the Park & Marine Research Facility and the new Berns Environmental Study Loop in the Moro Canyon section of Crystal Cove State Park.
